

Dear Mr Alexander de Croo, Dear Ms Sarah Schlitz, Dear Mr Vincent Van Quickenborne, Dear Ms Annelies Verlinden,

We are writing to express our deepest concern regarding the numerous testimonies of women who publicly stated around mid-October that they were victims of sexual violence, in Brussels and in Gent. We learned that these women were drugged and sexually abused and that these violations have been going on for several years, suggesting a pattern of sexual violence that goes well beyond isolated cases.

Moreover, neighbours of the affected areas have expressed that they were aware of some of the attacks and of the unsafe climate for women in the neighbourhood. In addition, most of the complaints that victims filed were closed and remain unpunished. The climate of tolerance and impunity this case shows is extremely worrying.

Since women publicly spoke about these abuses, there have been a few demonstrations in Brussels calling for an urgent institutional response and for ending the rape culture that allows sexual violence to spread. We, as Members of the European Parliament, stand in solidarity with the women taking the streets and especially to those who have suffered sexual violence: we believe you.

We echo their demands to adopt strong measures to investigate and to prevent further aggressions. We recall that Belgium is a signatory of the Istanbul Convention and that, as such, it should uphold a comprehensive framework, policies and measures for the protection of and assistance to all victims of violence against women, including sexual violence. In parallel, we have been informed that the Belgian government is amending the current criminal code regarding sexual violence and that several women's grassroots organizations are interested in contributing to the process.

All in all, as Members of the European Parliament, we ask you to ensure:

-The immediate closure of the bars where sexual aggressions took place until investigations are fully conducted;

-The opening of centers for victims of sexual violence around the country as it was agreed at the government level to make sure all victims access the necessary services;

-To reopen and further investigate the aforementioned complaints that were closed, in order to identify and condemn the perpetrator(s);

-To include women's organisations in the debate regarding the amendment of the criminal code;

-To use all means to put an end to the rape culture that lies behind sexual violence and to enforce the Istanbul Convention commitments.
